## **Cookie Policy**

#### 1. Introduction

When you visit <u>www.bielik.io</u>, use the related website or use the Bielik application, Bielik may use cookies and similar technologies to collect information about you. Because Bielik Vault sp. z o.o. and

Bielik Operations sp. z o.o., hereinafter referred to as "Bielik," respect your privacy and treat your information, including personal information, with due care, this "Cookie Statement" explains what these technologies are and why we use them, as well as your rights to control their use by Bielik.

We are responsible for the use of cookies on our websites and applications. To contact Bielik about our use of cookies, please use the contact information at the bottom of this Cookie Statement. This Cookie Statement is part of the User Agreement and uses certain terms defined therein.

#### 2. What are cookies?

Cookies are small text files that websites place on your device when you browse the web. They are processed and stored by the web browser. A cookie allows data (potentially including personal information) to be stored on a user's device and retrieved from that device. Cookies themselves are widely used for the proper functioning of a website, to enhance its performance, and to provide information to website owners. Cookies can also be easily managed, as well as deleted from your browser.

## 2.1 Cookie validity period

The length of time a cookie remains on a user's device depends on whether it is a persistent or session cookie:

- 1. Session cookies: these cookies are temporary and expire when you close your browser (or end your session).
- 2. Persistent cookies: this category includes all cookies that remain on the user's hard drive until they are deleted by the user or the browser, depending on the specified retention period of the cookie (mentioned in Section 3).

## 2.2 Source of cookies

Cookies can be placed by several entities, as explained below:

- 1. Own cookies: are placed on the user's device directly by Bielik.
- 2. Third-party cookies: these are cookies that are placed on your device in connection with your visit to the Bielik website by a third party, such as an advertiser or analytics system.

Please note that while we use (some) of the information collected by third-party cookies, we do not control the types of information collected and stored by third-party cookies themselves. If you would like more information on this, please check the third party's website for more information on how cookies are used.

## 3. What types of cookies do we currently use and why?

Bielik uses cookies for essential or functional purposes and for analytics.

Whenever you consent, cookies are also used to, among other things, display advertisements and other relevant information on topics of interest to you, perform campaign analysis and reach targeted audiences.

Below is a list of the cookies we currently use, along with information about the category of cookie, the provider, the purposes for which it is used, the validity period of each cookie, and the legal basis for processing personal data through these cookies.

### 3.1 Necessary and functional cookies

We use essential cookies that are necessary to make our site function properly from a technical point of view. Other cookies are used to provide site functionality, such as the ability to save or remember preferred settings.

We process the following necessary and functional cookies:

## 3.2 Analytical cookies

We use analytical cookies to collect information about the use of our Site. The information collected by these cookies is used to provide information about the quality or effectiveness of our Site. The data we collect through analytical cookies may include the most frequently visited Web pages, time spent on a particular page, or error messages on certain pages.

We process the following analytical cookies:

Google Analytics is used by Bielik for analytical purposes, for which the user's prior consent is usually required. However, since Google Analytics is used by Bielik in a privacy-friendly manner - as recommended by the Dutch data protection authority - prior consent is not required. Bielik has taken the following measures:

- 1. Has entered into a data processing agreement with Google.
- 2. Does not show the last 8 digits of the user's IP address to protect the user's privacy.
- 3. Disabled Google's data sharing option.
- 4. Does not use other Google services in conjunction with Google Analytics cookies.

## 4. Change cookie settings

When you visit our Website for the first time, you choose whether to accept cookies. You can manage your cookie settings on our website.
