Referral Program Terms and Conditions - Bielik Platform

I. General Provisions

- 1. These Terms and Conditions define the rules of the Client Referral Program (hereinafter referred to as the "Program").
- 2. The Program is organized by the Bielik Platform, which enables the purchase and sale of cryptocurrencies.
- 3. Each Participant is required to read and accept these Terms and Conditions, which outline the rules and eligibility criteria for participation in the Program.
- 4. The Terms and Conditions are available on the Organizer's website and at its registered office.

II. Definitions

- 1. Organizer Bielik Platform, a provider of cryptocurrency purchase and sale services.
- 2. Referring Client / Referrer A natural person with full legal capacity who refers a new client to register and purchase cryptocurrencies via the Bielik Platform.
- 3. Referred Client A natural person who registers on the Bielik Platform and purchases cryptocurrencies as a result of the Referrer's recommendation.
- 4. Participants A collective term referring to both the Referrer and the Referred Client.
- 5. Reward A benefit granted to the Referrer for a successful referral.

III. Program Duration

- 1. The Program is valid until further notice from the Organizer.
- 2. The Organizer reserves the right to extend, shorten, or terminate the Program at any time, without providing justification.
- 3. Information about any changes to the Program will be published on the Bielik Platform or its official social media channels.

IV. Participation Rules

- 1. Participation in the Program is voluntary and free of charge.
- 2. Joining the Program implies acceptance of these Terms and Conditions.
- 3. A Referring Client cannot simultaneously act as a Referred Client.
- 4. To make a valid referral, the Referrer must provide the prospective client with a unique registration link.
- 5. The Referred Client must register using the received link and purchase cryptocurrencies via the Bielik Platform.

V. Benefits

- 1. To qualify for the reward, the following conditions must be met together:
- a) The Referred Client registers on the Bielik Platform using the referral link;

- b) The Referred Client makes their first cryptocurrency purchase of at least 30 PLN.
 - 2. For each successful referral, the Referrer will receive a reward of 40 PLN.
 - 3. The reward may be exchanged for cryptocurrencies via the Bielik Platform.
 - 4. The Referrer may withdraw the reward no earlier than one full calendar month after it has been credited to the user's account, as specified in Section V.5. The reward may only be withdrawn on the condition that all Referees invited by the Referrer are actively using the services of the Bielik Platform on the day of the withdrawal, i.e., they maintain an active account.
 - 5. The reward will be credited to the account created on the Platform within 7 business days from fulfillment of the above conditions.
 - 6. A Referrer may receive a reward for each successfully referred new client.
 - 7. A "new client" is defined as a person who has never held an account on the Bielik Platform.

VI. Tax Obligations

- 1. Each Participant who receives a reward is solely responsible for reporting and settling the resulting income under the applicable Polish Personal Income Tax (PIT) laws.
- 2. Bielik Platform is not responsible for Participants' tax settlements and will not act as a PIT tax payer in relation to rewards issued through the Program.
- 3. Bielik Platform may only fulfill reporting obligations in accordance with Polish tax regulations, in particular by providing required information to tax authorities, if applicable.

VII. Complaints

- 1. Complaints regarding the Program may be submitted during its duration and within 60 days after its conclusion.
- 2. Complaints should be submitted via email to the Organizer's contact address.
- 3. The Organizer will review and respond to the complaint within 14 business days of receiving it.

VIII. Final Provisions

- 1. These Terms and Conditions are effective from the date of publication.
- 2. Participants are required to comply with these Terms and Conditions as well as the Terms of Use of the Bielik Platform and the Terms of Payment Services, insofar as these are not regulated herein. Acceptance of these Terms implies acceptance of the aforementioned documents.
- 3. The Organizer reserves the right to modify the Terms and Conditions at any time.
- 4. Each Referrer may receive rewards for a maximum of 25 successful referrals. The total value of rewards must not exceed 1,000 PLN. This limit remains in effect until revoked or amended by the Organizer without prior notice to Participants.
- 5. The data controller of the Participants' personal data is the Bielik Platform.

- 6. Personal data is processed in accordance with applicable data protection laws and used solely for the purpose of executing the Program.
- 7. Any matters not covered by these Terms and Conditions are governed by the provisions of the Polish Civil Code and other applicable laws.
